TAX ADVISE



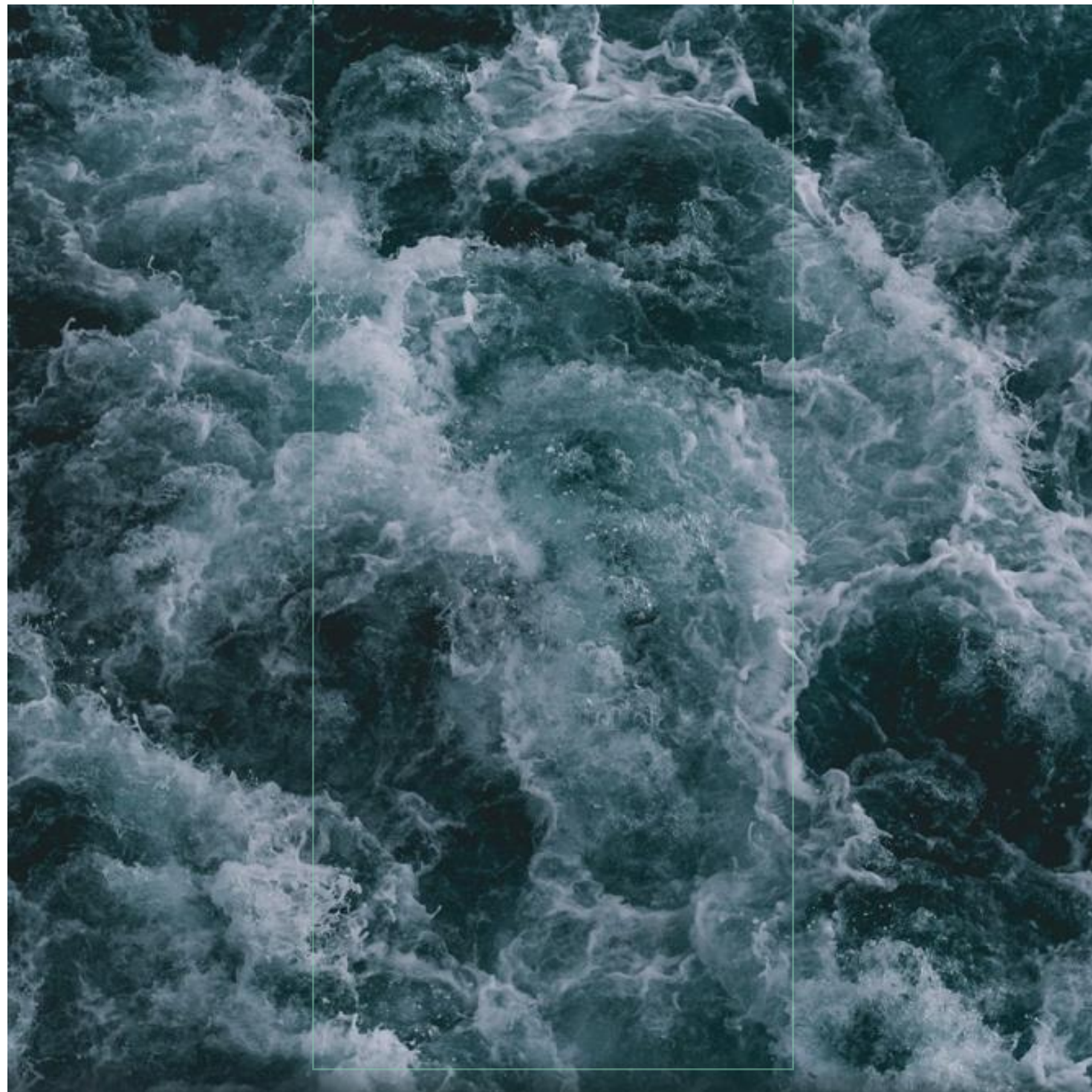
- Assistance in complying with tax obligations
