The aim is to contribute to improving the competitiveness of SMEs in our region thanks to a digitalization process that allows the organizational changes necessary to increase their productivity.

## Grant Intensity

- The amount of the subsidy depends on the type of expense presented, the size of the company and its geographical location. In any case, it is limited to €250,000 for medium-sized companies and €350,000 for small companies.
- Expenses derived from the acquisition, renewal or extension of material or intangible investments and external consulting for projects related to the introduction of digital technologies in the company, such as: collaborative platforms, cybersecurity, additive manufacturing, sensors, etc. are subsidized.

## Grant purpose

Grant for industrial research and experimental development projects, as well as innovation projects in terms of organization and processes that contribute to the digital transformation of industrial companies and the improvement of their environmental sustainability as a consequence of their digitalization.

Companies with their own legal personality, legally incorporated in Spain and duly registered in the corresponding registry, regardless of their size, that have been developing an industrial activity for a period of at least three years counting until the end of the application period and that are not part of the public sector
